The Scrapbooking Club's Constitution

ARTICLE I – Scrapbooking Club

The name of this organization shall be the Scrapbooking Club hereafter referred to as the Scrapbooking Club. We are not affiliated with any other group or organization.

ARTICLE II – PURPOSE

The purpose of this organization shall be to scrapbook and make a variety of different crafts.

ARTICLE III – MEMBERSHIP

- Section 1. This organization is open to anyone who desires to participate, we will not discriminate against anyone based on their race, sex, ethnicity or in any other discriminatory way.
- Section 2. Associate membership in this organization shall be open to any part-time student, graduate student, seminary student, faculty member, staff member or administrator at the University of Dubuque.

ARTICLE IV – OFFICERS

Section 1. Officers of the organization shall be as follows:

- Section 2. Election of Officers: The current officers will elect new officers before they retire.
- Section 3. Duties of Officers.
- President: Arranges times and dates of meetings. Organizes fundraisers.

Creates ideas and thinks of crafts. Makes sure everyone is getting along and having fun.

Vice-President: If the President is absent the vice-president is in charge. Follows through with crafts, creates ideas. Will guide members through each step of each project and clarify any details.

Secretary- Will take attendance and keep records. Will notify members of the meeting times and if the group cannot meet for any reason.

ARTICLE V – MEETINGS

- Section 1. A regularly scheduled general meeting shall be held at least once a month. As of now, the meetings will be held every Wednesday from 3:00pm-4:30 pm.

Section 2. All amendments require a 2/3 vote of a quorum for adoption.
