The Opportunity

The University of Dubuque (UD) seeks an innovative, strategic, and values-driven Vice President for Finance and Administration to lead UD's financial and operational strategy in alignment with its mission and long-term goals.

Reporting directly to the President and serving as a key member of the Cabinet, the Vice President for Finance and Administration provides executive leadership for financial planning, accounting, budgeting, investments, facilities, risk management, and administrative operations.

This is a pivotal moment in UD's history – building on more than two decades of remarkable transformation that have strengthened the University's academic programs, physical campus, and financial foundation. With an endowment exceeding \$350 million, sustained enrollment, and a culture of stewardship and innovation, UD is well positioned for continued success.

Continuing the work of his predecessors, President Frampton has already initiated significant advancements in his first year, including the process of establishing the John and Alice Butler College of Osteopathic Medicine (proposed, applicant seeking accreditation), a major expansion of the aviation program and the Edward Babka Aviation Learning Center, and the construction of the 75,000-square-foot Chlapaty Center for Innovation.

The Position

The Vice President for Finance and Administration serves as the University's chief financial strategist and operational leader, responsible for advancing institutional priorities through prudent management, strategic foresight, and collaborative leadership.

- framework and ensure compliance with regulatory and accreditation standards.
- Provide strategic leadership for facilities, capital projects, and campus operations.
- Partner with Cabinet colleagues to advance institutional priorities and foster a culture of transparency and accountability.
- Manage key relationships with financial institutions, auditors, and investment advisors.
- Collaborate with community partners.

Areas of Oversight

The Vice President for Finance and Administration supervises a dedicated team of professionals overseeing:

Finance Department: Associate Vice President for Finance (1), Controller (1), Assistant Controller (1), Payroll (1), Student Accounts (2), Staff Accountants (2), and a Collections Manager (1); Facilities Department: Director (1), Assistant Director (1), Office Manager (1), Maintenance (8), Custodians (20), and Groundskeepers (6);

Auxiliary Services: Print/Mailroom (1) and Merchandise Manager (1); and

Technology: Director (1), Data Management (1), Media Services (1), Systems Administrator (1), and Help Desk (1).

Key Opportunities and Priorities

- Collaborative Leadership: Build strong partnerships across campus and within the Dubuque community to align financial strategy with mission.
- Strategic Stewardship: Lead long-term financial modeling and sustainability planning in an evolving higher education landscape.

- Campus Infrastructure: Oversee continued investment in UD's facilities to support academic innovation and student experience.



- Mission Integration: Model values-based leadership that reflects UD's welcoming Christian ethos and commitment to service.
- Community Partner: Build community relationships and strengthen partnerships that help establish the University as a knowledge enterprise in the Tri-State area.

- Master's degree in Finance, Accounting, Business, or related field as well as CPA or equivalent credential.
- At least 10 years of progressive financial leadership, preferably in higher education or non-profit settings.
- Demonstrated success managing complex budgets and implementing multi-year financial strategies.
- Strong understanding of GAAP, audits, and compliance in nonprofit and higher education environments.

Attributes and Qualifications (Preferred)

- Experience overseeing facilities, capital projects, or auxiliary services.
- Familiarity with enterprise systems (e.g., Jenzabar or similar ERP).
- Demonstrated ability to lead teams and foster inclusive, values-based work cultures.

The University of Dubuque and Dubuque Community

The University of Dubuque's long and distinctive history began in 1852 with the vision of Dutch immigrant Rev. Adrian Van Vliet. He would eventually settle in Dubuque to prepare young pastors through what became known as the Van Vliet School, for the ministry of Germanspeaking populations crossing the Mississippi River to settle in Iowa and further west and northwest. Over the next 50 years, the institution underwent multiple name changes. In 1911, the school was introduced, and it was not until June 17, 1920, when a new charter was issued along with the new name of the University of Dubuque.

Guided by its Mission, today UD is moving forward in dynamic ways, with a robust endowment, sustained enrollments, a strong foundational infrastructure through consistent attention to campus-wide renovations and new construction, and a strategically balanced dynamic curriculum that informs UD's Student Success Commitment.

A distinctive campus culture committed to radical hospitality, today UD students are moving forward being shaped and led by their experiences in and out of the classroom where they are challenged to be empathetic, brave, relentless, and inspired. UD students are measured not by whom they are when they arrive on campus, but ultimately by who they become during their time at the University of Dubuque, as they move out in leadership and service in their chosen professions and their communities.

UD's 77-acre campus with ongoing projects position us to surpass \$400 million in infrastructure development by October 2027, reflecting steady growth over the last two decades. Areas of Study

The University of Dubuque offers 31 undergraduate areas of study as well as graduate programs in Business, Communication, Physician Assistant Studies, and Theology. The most populous undergraduate programs at UD include Aviation, Natural and Applied Sciences, Business and Marketing, Education, Wellness and Exercise Science, and Sport Marketing and Management. UD will be adding an Engineering program projected to begin fall 2027.

The University of Dubuque Theological Seminary offers degree programs and certifications for several denominations including Presbyterian Church (USA), United Methodist and Global Methodist, and United Church of Christ.

An adult-accelerated degree program is also offered through our Learning Institute for Fulfillment and Engagement (LIFE) with eight undergraduate degrees and four graduate degree options. LIFE is accessible online and on the Dubuque and Cedar Rapids, Iowa, campuses. UD is also adding UD Global, an online, asynchronous, seven-week program in the summer 2026.
